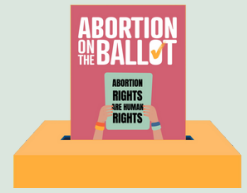

Elections for U.S. Senate, U.S. House, statewide elected offices, State Senate, State Assembly, and other local elections

The November 8th midterm election marks the first time people across the United States have an opportunity to stand up for reproductive freedom following the landmark Supreme Court decision overturning the 50-year abortion rights precedent set by Roe v. Wade. Abortion is quite literally on the ballot and this fact sheet aims to inform voters about what is at stake in Nevada.

Current State of Abortion in Nevada

Abortion is currently legal up to viability (24 weeks) in Nevada. The Democrat-controlled Legislature has passed legislation protecting access to abortion. Governor Sisolak has issued an executive order providing protections for providers and those traveling from out-of-state for an abortion.

The Party Divide on Reproductive Rights Conversations

Democrats this election cycle are talking about protecting a person's reproductive rights, and Republicans want to criminalize reproductive choice and prevent access to care.
